The purpose of the Academic Enrichment Grants are two-fold to support teachers and to fund innovation in the classroom or building. Front line employees like teachers and principals are best at both identifying problems and developing solutions. The foundation partners with them to first fund these grants, and if proven valuable to student learning, replicate these solutions across the District. Last year, 26 grants were funded which in one year, positively impacted the education of 15,453 students. Most grants have multi-year impact.

4b (Code:) (Expenses \$ 94,919 including grants of \$ 84,669) (Revenue \$)

Pre-K Summer School provided 120 students from every school in the district at three sites with 4 weeks of intensive pre-school instruction. These students were identified during the Kindergarten Round-up process as being the "least ready" among their peers to start Kindergarten. In addition to learning numbers, colors, letters and sounds, students also learned critical classroom behaviors which help facilitate a conducive learning environment for other students. Transportation was provided to ensure all students had access to this opportunity and 80% of parents attended during the last week of school to become acquainted with the school and the resources available to their student.

4c (Code:) (Expenses \$ 224,233 including grants of \$ 200,020) (Revenue \$)

Dedicated Fine Arts-Fund Annual investment in Band, Orchestra, Choir, Drama and Visual Arts programs at every middle and high school in the Issaquah School District. Programs are funded on a 4-year rotational basis. Funds this year were used to replace and refurbish orchestra instruments as well as purchase much needed Choir and Drama music and equipment. This investment enriches the education and lives of over 2,000 students grades 6-12.
